NORTH CENTRAL REGIONAL ASSOCIATION OF STATE AGRICULTURAL EXPERIMENT STATION DIRECTORS

WHEREAS Shawn S. Donkin, PhD., Professor of Agricultural Animal Sciences, Associate Director of Agricultural Research, Assistant Dean in the College of Agriculture at Purdue University has resigned his position as of August 2021 after completing 25 years of outstanding research, teaching, outreach, and administrative service,

WHEREAS Dr. Donkin began his post-secondary education at Nova Scotia Agricultural College in Truro, Nova Scotia and earned a B.S. in Agricultural Sciences in 1982 from McGill University. He then served as a Field Representative for Shur-Grain Feeds and as a Dairy Herd Manager at Biodalosy Farms where he grew to understand industry needs and the perspective of stakeholders before he returned to school to earn a M.S in Dairy and Animal Science from the Pennsylvania State University and a PhD in Dairy Science with a minor in Biomolecular Chemistry from the University of Wisconsin - Madison,

WHEREAS Dr. Donkin joined the faculty of Purdue University in Animal Sciences in 1995 with a research and teaching appointment and led an internationally-recognized research program that supported food animal production, animal well-being, and human health,

WHEREAS Dr. Donkin has engaged in scholarly activity, where he authored or co-authored over 110 referred publications, more than 130 abstracts, 16 research reports, and 6 book chapters. He was an also a dedicated and active mentor to undergraduates, graduate students, and postdocs and fully committed to developing the next generation of researchers and scholars,

WHEREAS Dr. Donkin's service to students, and particularly graduate students, included developing programs and initiatives that supported graduate education including assessment, student recruitment, admissions, academic services, diversity, inclusion, fellowship program funding, professional development, and communications. He was a champion for initiatives that directly supported graduate students and enhanced the graduate experience,

WHEREAS Dr. Donkin has been distinguished as a recipient of many awards including Outstanding Teacher, Outstanding Graduate Mentor and Outstanding Undergraduate

Counselor and the Purdue Dreamer Award in 2020 for contributions that embody Rev. Martin Luther King Jr.'s vision of service to others and further the University's commitment to diversity,

WHEREAS Although Dr. Donkin does not have a formal extension appointment, he participated in numerous outreach activities. Dr. Donkin had been a regular contributor to the Tri-State Dairy Nutrition Conference as well as nutrition conferences nationally. He has contributed to outreach through extension publications, producer field day participation, youth activities, and individual consultations with livestock producers. For his efforts he was recognized with the Indiana Extension Educators Association International Award,

WHEREAS Dr. Donkin provided excellent leadership to the NCRA as the NCRA representative on the ESCOP Budget and Legislative Committee; NCRA resolutions chair and as Administrative Advisor to multistate research committees NCAC2, NC1213, and NC2042,

WHEREAS We wish that Shawn finds his dreams in Oregon, that the smoke clears, the rains gently come, the pastures green and the crops grow. May funding flow abundantly and enable him to implement all that he envisions in his new work life. A smart, kind, caring, hardworking, perceptive person like Shawn deserves it to be so,

NCRA ENHANCEMENTS TO THE MULTISTATE RESEARCH PORTFOLIO

last update: 9/15/2021

The 12-state North Central Regional Association of State Agricultural Experiment Station Directors (NCRA) manages a portfolio of multistate research (with some integration of Extension and teaching) projects with diverse priority areas that stimulate collaborative, value-added, coordinated, synergistic research-led projects. Once operational, these 5-year projects methodically and incrementally advance science and education across NC and other participating states. Faculty-led projects with other institutions, state and federal agencies, countries, and the private sector are common. Most projects submit multiple project renewals.

To further increase national impact and stimulate a higher level of collaborative NC research across institutions, NCRA directors have agreed, as a pilot, to support a focused, innovative, high quality, and action-oriented NC-led research project that will have immediate impact within a two-year timeframe. In addition, the project must have <u>true collaborations</u> that <u>synergize activities across participating states</u> rather than independent efforts that are merely compiled. We encourage partnerships with existing NC multistate projects, states and other regions, as these may enhance impacts. The existing 500-series of multistate framework would be efficient and appropriate for this application given the use of federal Hatch Multistate Funds. As these are capacity funds, no indirect costs are allowed.

The thematic focus for the current round of funding is on **climate change.** Directors' priorities may change foci with future calls. A total of \$60,000 is available from the NC Hatch Multistate funds and it is anticipated that one proposal will be funded. The maximum request for a single proposal is \$60,000 for a duration of up to two years. In addition, proposals <u>must</u> integrate a DEI (diversity, equity, inclusion) component from inception, such as with a partner from an 1890 and/or 1994 Land-grant institution. At the end of the one- or two-year project, a formal presentation will be given to NC directors. Deliverables are expected to be multi-institutional, multi-disciplinary, and include action-oriented items such as a planning grant leading to successful team competitive grant submissions; development of new technologies and SBIR proposals.

Applicants should submit the following:

1) Proposal not to exceed four pages.

- 2) Direct involvement of at least four North Central region states (and other entities).
- 3) Proposal format
 - a. Title
 - b. Project Directors/co-directors and NC state affiliations
 - c. Project Justification and Challenges to be Addressed
 - d. Multistate Project(s) Involved and Leveraged
 - e. Collaborative Approaches
 - f. DEI integration
 - g. Action-oriented Expected Results and Impacts
 - h. Detailed budget and justification (federal Hatch funds as graduate research assistantships, hourly labor, equipment, supplies, travel, publications)
 - i. Additional participants (not counted in four-page limit)

North Central Communicators Pilot Project (from 2019)

The Agricultural Experiment Station's (AES's) research portfolio in the North Central Region (NCR) is some of the most innovative and impactful work within a state, and across the region, nation and globe. NCRA directors believe that a multi-faceted effort by North Central Region communicators would significantly increase the quality and overall impact from our communication efforts by sharing and improving 'best practices' across NC audiences. As a pilot discussion, communicators from IA, MN and NE will convene electronically to develop a succinct DRAFT North Central plan to present and discuss with North Central directors at our next meeting in Manhattan, KS during July 28-30.

The How --, To Who --, When -- and Why -- this work is communicated is pivotal to our current and future success. Influential stakeholders who use and support the research work, and the public must have some educated perspective on the value and impact of this on-going investment into research. This effort would strive to leverage and enhance our region's prominence with impactful research and build upon other existing successful communications efforts.

This agenda may include:

- 1) Survey or inventory of current NC communication strategies and products
- Sharing of best practices for communications with different audiences
- Adaptation of current and future technologies to NC communications
- 4) Development of NC training materials and programs for faculty
- 5) Development, delivery and archiving of (quarterly) training for faculty to communicate their work better, developed through a NC rotation of communicators
- 6) Creating a community of NC communicators
- 7) Other
